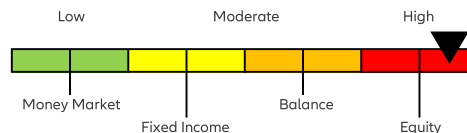

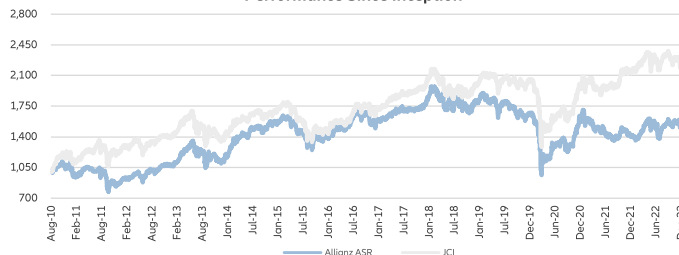

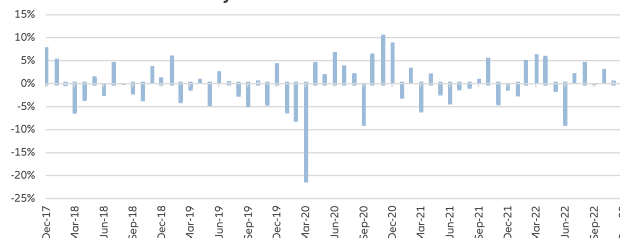
## Risk Description
